On January 2, 2025, the fair value methodology used to value emerging markets debt held by the Artisan Partners Global Funds was changed from using bid pricing to using the midpoint between the bid and ask price. The change resulted in a one-time increase of less than 0.40% in the net asset value for Artisan Emerging Markets Debt Opportunities Fund.
