## Portfolio Construction

- Typically 30–40 holdings
- Maximum position size generally 5%<sup>1</sup>
- Position sizes determined in part by how well a company meets the team's margin of safety criteria
- Attention to economic exposure
- Typically less than 15% cash

A large margin of safety may help guard against permanent capital loss and improve the probability of capital appreciation.
