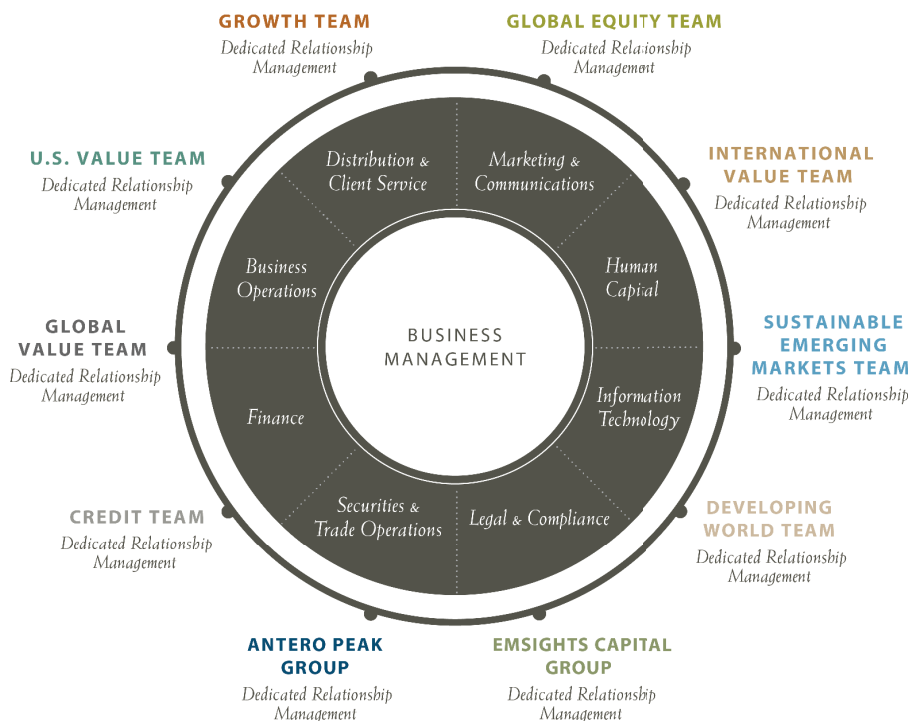

Business Model

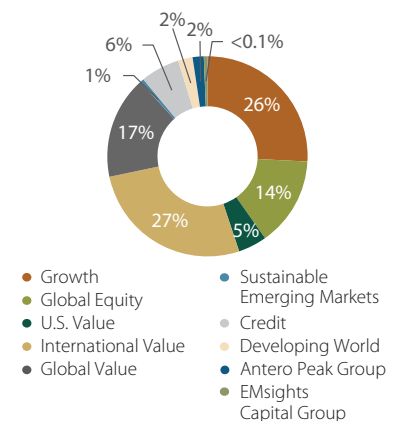

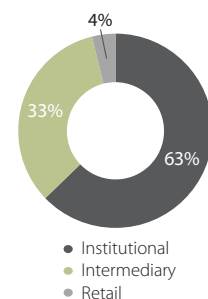

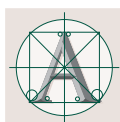
