Commentary

Solid corporate earnings and a market-friendly first-round French election outcome buoyed non-investment grade credit markets in April as risk markets brushed off a weak Q1 US GDP report and rising geopolitical tensions. Roughly halfway through earnings season, companies are reporting their best quarterly revenue and earnings growth since 2011. Overall, the BAML Index was up 1.1%, while the JP Morgan Leveraged Loan Index finished up 0.4%. Our portfolio modestly outperformed the BAML Index, aided by our bond holdings in the health care, media and services sectors.

High yield bond yields declined 32bps, finishing the month at 5.6%, a multi-year low, while spreads tightened by 20bps to 388bps—only 13bps above the multi-year lows set in early March. Loan yields similarly dropped 15bps to 6.0% and spreads compressed 7bps to 429bps.

By ratings, higher-rated bonds outperformed in April for the second consecutive month, after lower-rated led consistently from February 2016 to February 2017. The majority of sectors had monthly total returns of 1% or better. The exceptions were utility, health care, energy and automotive.

Default activity remained relatively subdued as three issuers defaulted on \$1.8 billion (\$250 million in bonds and \$1.5 billion in loans). The par-weighted US high yield default rate declined to its lowest rate since March 2014 as the last 12 month calculation removed \$32.0 billion of defaulted debt occurring in the first four months of 2016, compared with only \$5.0 billion added YTD.

Portfolio positioning was largely unchanged month over month. Our weightings increased in the basic industry and services sectors as we identified new opportunities that met our criteria for business quality, financial strength, downside analysis and valuation. Conversely, our exposure to the insurance sector fell as USI, a leading US insurance broker, was recently acquired by private equity firm KKR.

Portfolio Construction

The team generally determines the amount of assets invested in each issuer based on conviction, valuation and availability of supply. Based on the team's analysis it divides the portfolio into three parts. Core investments are generally positions with stable to improving credit profiles and lower loan to value ratios. Spread investments are those where the team has an out-of-consensus view about a company's credit improvement potential. Opportunistic investments are driven by market dislocations that have created a unique investment opportunity. Allocations to each group will vary over time based on market conditions.
