# Commentary

Top month-to-date contributors: US Bancorp; Meta Platforms Inc; Netflix Inc; The PNC Financial Services Group Inc; Bank of America Corp

Bottom month-to-date contributors: The Cigna Group; Schlumberger NV; Arch Capital Group Ltd; EOG Resources Inc; Merck & Co Inc

In this space, we discuss one top contributor (US Bancorp) and one bottom contributor (Cigna) from the recent month.

A huge rally in the Treasury market—its best month since the 1980s—that was driven by easing inflation and other signs that the Federal Reserve is likely done hiking interest rates, as well as increased hopes of a US economic soft landing, led to strong gains by cyclical stocks, including bank shares such as US Bancorp (USB). When bank stocks sold off in Q1 due to fears of contagion following Silicon Valley Bank's failure, we took advantage of the market dislocation by purchasing USB, along with PNC Financial—another top 10 US bank—at cheap prices. USB is a bank we have known for years. It is well managed and has a solid balance sheet. As one of the largest banks, it was less impacted by the turmoil that affected smaller institutions as depositors sought the safest places to store their money. However, the dynamic of low-cost deposits flowing out of the system and into higher yielding money markets and bond markets, the increased price competition for remaining deposits and the inverted yield curve are headwinds for bank earnings prospects generally. Nevertheless, we believe the range of probabilities and long-term outcomes are tilted in our favor at current valuations.

Shares of Cigna fell on reports of a potential merger with Humana that would combine two of the US' largest managed care companies. The deal makes strategic sense as it would significantly increase Cigna's scale and provide greater diversification to earnings given minimal business overlap. However, the US health care market is already highly consolidated, so regulatory approval could be a challenge. Whether the deal gets done or not doesn't materially impact our investment case. Cigna is one of the few managed care organizations in the US with the scale and size to compete effectively. The company consistently generates significant free cash flow, much of which is returned to shareholders via buybacks and dividends. In 2022, free cash flow was \$7.4 billion, up \$1.3 billion from 2021. Cigna paid down \$3.5 billion of debt, repurchased \$7.6 billion in stock and sold its life, accident and supplemental benefits business in Asia to Chubb, which helped fund the share repurchases. In short, the business is performing well, and management has shown prudent capital allocation. Additionally, the stock is selling cheaply, for less than 10X next year's earnings.
