Artisan Partners Global Opportunities Fund Receives Best Mutual Fund Award for 2022

The Artisan Global Opportunities Fund, managed by the Growth Team, was ranked fourth within the Best International Stock Funds category, based on its 10-year average annual return. The Team previously won the award in 2021 for the Artisan Small Cap Fund ranking fifth in the Best Small Cap Funds category.
