**Mark L. Yockey, CFA** is a Managing Director of Artisan Partners and a portfolio manager on the Global Equity team. In this role, he is a portfolio manager for the Non-U.S. Growth, Non-U.S. Small-Cap Growth and Global Equity strategies.
